

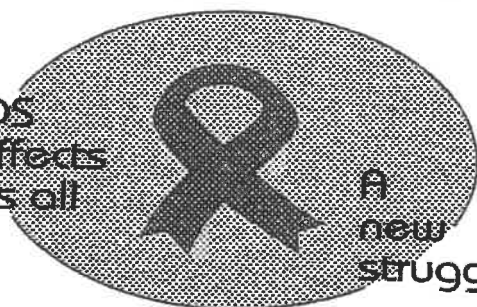



RE: MOTIVATIONAL REASONING FOR NOT ALLOWING CONSUMPTION OF ALCOHOL BEVERGAGES

- 1) The Supabets Group of Companies has been operational since approximately 2008.

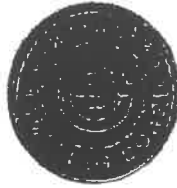

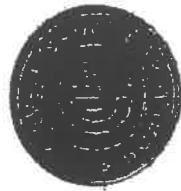

TERMS AND CONDITIONS

1. The licence shall be established and operated in accordance with the provisions of the laws of the Republic of South Africa, the Gauteng Gambling Act, No 4 of 1995, as amended (the Act), any regulations or rules made under the Act, the terms and conditions of the licence and directions given by the Gauteng Gambling Board from time to time.
2. The licensee shall ensure that:
 - 2.1 all installations, equipment and procedures for security and safety purposes are used, operated and applied in a manner which will best serve the interest of the public;
 - 2.2 operations are conducted at all times in a proper and competent manner;
3. The licensee shall submit to the Board guarantees in a form acceptable to the Board for liabilities of the licensee in relation to:
 - 3.1 taxes payable in terms of the Act,
 - 3.2 gambling debts payable by the licensee,
 - 3.3 the guarantees referred to in paragraph 3.1 and 3.2 shall be maintained at such levels as may be determined by the Board from time to time.

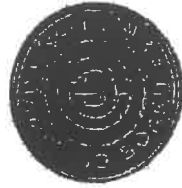

4. The licensee shall comply to the satisfaction of the Board with all undertakings given in its licence application and stipulations issued by the Board based on the aforesaid undertakings
5. The licensee shall not enter into any management agreement in respect of the licensee's business or amend the terms and conditions of such agreement without the prior written approval of the Board.
6. The shareholders of the licensee shall not enter into any shareholders agreement or amend the terms and conditions of such agreement without the prior written approval of the Board.
7. This licence is a revocable privilege contingent upon continuous suitability for licensing.
8. The licensee shall, in the conduct of its business, deal only with reputable third parties.
9. The Board may in terms of Section 37 of the Act impose on the licensee certain penalties for failure to comply with, or contravention of, any term or condition of this licence, which includes inter alia, suspension or revocation of the licence.
10. The licensee may not cease operations without the approval of the Board.
11. The licensee shall make use of approved equipment and devices and shall not without prior approval of the Board effect changes, notifications or upgrades to the approved bookmaking system.
12. The licensee shall submit for approval minimum internal controls certified by its accountants.
13. The licensee shall in respect of employees:
 - 13.1 register employee(s) in terms of section 59 of the Act read with regulation 263 and 264
 - 13.2 notify the Board within 14 days of termination of employment of employee(s)
14. The licensee shall not amend or vary its betting rules without prior approval of the Board.

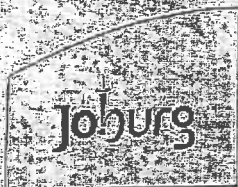


15. This licence shall, subject to section 37 of the Gauteng Gambling Act, be valid indefinitely.

Your enquiry of 5 November 2021 has reference:

Based on the zoning information provided, the zoning of "General" in terms of the City of Johannesburg Land Use Scheme, 2018, permits all uses except noxious industries. As such, the proposed place of amusement (sports betting / bookmaker & totalisator and 5-LPM) is in line with the zoning in so far as the land use is concerned.

It should be noted, however, that in terms of the City of Johannesburg Land Use Scheme, 2018, the submission of a site development plan is required, which would address *inter alia* the position of the structures, development controls, parking, access, mitigating measures, etc.

It must be stated that the views/opinions and information herewith contained are provided without prejudice to whatever information may in future be provided to or attained by Council, and Council would be at liberty to later amend or review its stance related hereto.
