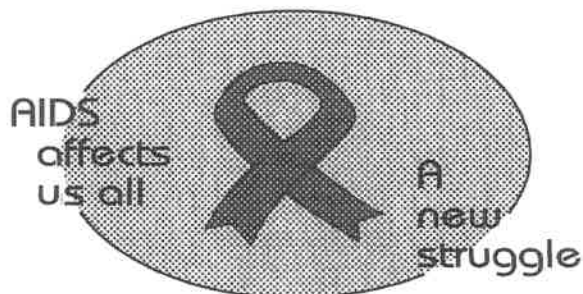

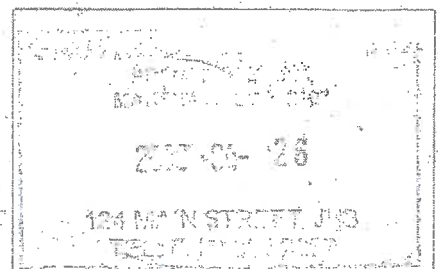

**SUBJECT: ZONING CONFIRMATION OF ERF 1389 ALBERTON**

Reference is made in reference to the above mentioned request.

1. That Erf 1389 of Alberton is zoned 'Industrial 2', with the permission to operate a Restaurant and five Gaming Machines, as per Consent Use number A282. *(Please see the Zoning Certificate).*
2. This means that this property is properly zoned for the operation of Gaming activities for a maximum of five machines as prescribed by the Ekurhuleni Town Planning Scheme of 2014, subject to the approval by Gauteng Gambling Board.
3. Other conditions applicable in the operation of the said activities on Erf 1389, entails the following:
  - a) Not more than 5 Limited Payout Gaming Machines will be allowed on the premises.
  - b) The operation of gaming machines shall be a secondary or ancillary activity to the main use.
  - c) Where persons under the age of eighteen (18) are permitted on the same premises where gaming machines are operated, the necessary control must be put in place to ensure that such underage persons are restricted from being able to access that part of the premises where gaming machines are operated and that such underage persons are not able to operate the gaming machines.

- d) The operator/owner of the gaming facility must comply with conditions and regulations as contained in the Gauteng Gambling Act 7 of 2004 and any other relevant legislation.
- e) The operator/owner of the Gaming facility must be registered with Gauteng Gaming Board.
- f) Before the operation of gaming machines is permitted, the operator/owner of the gaming facility must first obtain the relevant license from Gauteng Gaming Board.
- g) The placing of notices/signs or plaques shall comply with the provisions of the Ekurhuleni Metropolitan Municipality Police Services By-laws Chapter 4 Advertisements, as well as the Ekurhuleni Policy on Outdoor Advertisement control as amended on 29 May 2010.
- h) The gaming activities or any other associated activities may not cause any nuisance to the neighboring residents and businesses.
- i) All relevant health legislation and requirements must be complied with.
- j) Clients must have access to sufficient and adequate ablution facilities.
- k) The activities may not create a noise nuisance as defined in terms of Noise Control Regulations-Gauteng (Government Notice 5479 of 20 August 1999).
- l) The owner/manager of the establishment must take full responsibility for the behavior of clients inside and outside the premises.
- m) All premises must comply with minimum safety requirements as per SANS 10400-part T.
- n) The total area to be used for the Limited Payout Gaming Machines shall not exceed 15m<sup>2</sup>.
- o) The consent shall lapse if the activity is not operated within one year after approval.
- p) The consent use rights shall lapse when exercising thereof is, at any time, discontinued, for a period of (15) fifteen consecutive months or longer.
- q) If all the conditions have not been complied with within a period of 7 months from the date of approval of the application, the consent use shall lapse.
